NOTICE OF CHANGE PETITIONS FOR RIPARIAN WATER RIGHT(S) REPORTED UNDER STATEMENT OF WATER DIVERSION AND USE NUMBERS S017293, S017319, S017388, S017392, AND S018230 OF RIVER PARTNERS

COUNTY: Stanislaus

STREAM SYSTEM: San Joaquin River

On March 19, 2020, Tuolumne River Trust on behalf of River Partners filed five petitions for change with the State Water Resources Control Board (State Water Board), Division of Water Rights (Division) pursuant to Water Code sections 1701 and 1707. The petitions request State Water Board approval for the addition of instream fish and wildlife preservation and enhancement as purpose and place of use for up to 7,020 acre-feet of water per year under one or more riparian water rights associated with the Dos Rios and Hidden Valley Ranch conservation properties in Stanislaus County. Water diversion and use claimed under these rights is currently reported under Statement of Water Diversion and Use (Statement) Numbers S017293, S017319, S017388, S017392, and S018230. Consistent with Water Code section 1707, subdivision (d), Tuolumne River Trust requests that water approved for instream use pursuant to the subject petitions be used to satisfy applicable federal, state, and local regulatory requirements governing water quantity, water quality, instream flows, fish and wildlife, wetlands, recreation, and other instream beneficial uses in the Sacramento-San Joaquin Delta. As of the date of this notice, the Division has not evaluated the scope or validity of the underlying riparian water rights.

Procedures for Filing Protests

Pursuant to California Water Code section 1703.1, any interested person may file a protest against approval of the subject petitions. Protests filed in response to this notice should be submitted to the entities and persons listed below and must be received by the Division no later than **APRIL 2, 2023**. The State Water Board may, for good cause shown, allow additional time to file protests. The protestant and the petitioner are expected to make a good faith effort to resolve the protest within 180 days from the close of the protest submission period.
