24	On August 6, 2020, the California Department of Water Resources ("DWR") filed a		
25	Complaint for Validation, thereby commencing Case No. 34-2020-00283112 (the "Validation		
26	Action"). On October 28, 2020, the Sierra Club and others filed a Petition for Writ of Mandate		
27	under the California Environmental Quality Act ("CEQA	der the California Environmental Quality Act ("CEQA"), thereby commencing Case No. 34-

Sierra Club v. California Dep't of Water Resources, No. 34-2020-800035117; Consolidated with California Dep't of Water Resources v. All Persons, No. 34-2020-00283112 2020-80003517 (the "CEQA Writ"). On February 26, 2021, the Court (Hon. Russell Hom, presiding) issued an order consolidating the two cases and designating the latter-filed case as the lead case.

On January 4, 2022, in connection with the CEQA Writ, the Court (Hon. Laurie M. Earl, presiding) issued an "Order after Hearing on Motions for Summary Judgment or Adjudication," granting summary judgment in favor of DWR and directing that judgment be entered denying the Petition for Writ of Mandate. Because the two actions had been consolidated, issuance of a final judgment on the CEQA Writ awaited resolution of the Validation Action.

On April 18, 2022, the Court (Hon. Michael G. Bowman, presiding) assigned this consolidated proceeding to the undersigned for all purposes.

On May 15-18, 2023, in connection with the Validation Action, the Court conducted a bench trial. The Court also received and considered extensive pre-trial and post-trial briefing. On August 25, 2023, the Court issued a proposed Statement of Decision, following which the Court received objections from DWR and responses from other parties to DWR's objections. The Court issued its Final Statement of Decision on January 16, 2024, finding DWR exceeded its statutorily delegated authority when it adopted the Bond Resolutions, which purported to authorize the issuance of the Delta Program Revenue Bonds.

Having received and considered the parties' evidence and argument, IT IS ORDERED, ADJUDGED, and DECREED THAT:

 The Petition for Writ of Mandate filed by the Sierra Club and others is denied and dismissed;

2. The Complaint for Validation filed by DWR is denied and dismissed; and

3. This consolidated proceeding, including both the CEQA Writ and the Validation Action, is concluded and therefore dismissed.
